- Rumblings about the 5% share of the tip pool fair labor standards issue
 - Full floors and up receive a share of the pool
 - The questions is can a salaried employee share a tip pool when they had n direct contact with the guest?
 - o 2 criteria
 - Is there a lot of guest interaction
 - Are these employees in typically tipped positions?
 - Jon Berrey Is this done in Vegas unknown
 - Josh Silar: there is nothing that says a salaried team member can't receive tips as long as you are not cutting the salary and supplementing with the tip.
 - John Berrey why are they complaining if they are benefiting? Those complaining stand to benefit if they remove the shift managers from the pool.
 - Josh feels they spend at least 8 hours in front of the guests.
 - John B Shift manager needs to note in the shift report how much they are on the floor dealing with the table games guests
 - John B Josh, table games manager, should not get a portion of the tip pool.
 Give him a raise to cover the different doing a great job and the department is in much better shape.

 - Jack says if we declare them as a tipped position as a tribal entity that should suffice.
