As part of our fiduciary responsibilities to the Quapaw Tribe, we are in the process of producing a RFP (request for proposal) to market test the RWI agreements for all tribal entities. I have attached the Agent of Record letters from Hays Companies to be approved and signed by each entity once approved by the relevant Board.

This is the process we used when market testing our Prescription Benefits Plan. We are experiencing a substantial savings on prescriptions benefits since we made the switch from MedTrak to MedOne. The Downstream Casino Plan has saved nearly \$400,000 in just prescription benefits. Plan members have also paid \$89,000 less out of pocket. A cost savings analysis is currently underway for the other plans and I'll be happy to share that data when it becomes available.
