RESOLUTION No. 062812-A

A RESOLUTION APPROVING A LETTER AGREEMENT BETWEEN THE DOWNSTREAM AUTHORITY, THE DOWNSTREAM GOLF CLUB, LLC, AND IBC BANK RELATING TO CERTAIN TRACTS OF LAND

- **WHEREAS,** the Downstream Development Authority of the Quapaw Tribe of Oklahoma (O-Gah-Pah) (the "Authority"), is an unincorporated entity wholly owned by the Quapaw Tribe of Oklahoma (O-Gah-Pah) (the "Tribe"), a federally recognized Indian nation; and
- **WHEREAS**, the Authority was created under the laws of the Tribe and authorized to develop, construct, manage, and operate the Downstream Casino Resort (the "Resort") and to engage in gaming pursuant to Tribal, federal, and state law on the Indian lands of the Tribe within the original Quapaw Reservation, as established as a homeland for the Quapaw Nation by the Treaty of May 13, 1833, *Quapaw Code* Title 17, § 101 *et seq.*; and
- **WHEREAS**, the Authority is expressly authorized to exercise its powers in the best interest of the Tribe, and to enter into agreements relating to gaming and other operations at the Resort; and
- WHEREAS, the Authority has entered into that certain letter agreement between the Downstream Golf Club, LLC (the "DGC") and with International Bank of Commerce ("IBC"), dated on or about June _____, 2012 (the "Letter Agreement"), setting forth certain agreements between the Authority and IBC concerning the payment of rents on certain DGC properties that are the subject of the "Lease Agreement" between the Downstream Authority and the DGC dated on or about June 1, 2012; and
- WHEREAS, pursuant to the Letter Agreement the Authority has agreed that, in the event the DGC defaults on its obligations on certain loan agreements with IBC, and in the event title to such properties is transferred to IBC or any other third-party, the Authority promptly will, upon notice by IBC, relinquish possession and control over properties to IBC (the "Property Surrender Clause"), and further will grant a limited waiver of its sovereign immunity to permit IBC to enforce such clause; and
- **WHEREAS**, the Authority desires to enter in to a that certain "Ratification of Letter Agreement" (the "Ratification Letter") with IBC and the DGC ratifying and confirming the Letter Agreement dated on or about February 18, 2011, by and among the DGC, IBC, and the Authority; and
- **WHEREAS**, the Authority has determined that it is desirable and in the best interests of the Tribe for the Authority to enter into the Letter Agreement.
- **NOW, THEREFORE BE IT RESOLVED THAT** the Authority hereby makes the following findings and determinations:
- 1. Findings of the Authority. The Authority hereby finds and determines that, although the Authority is not a party to the loan agreements between the DGC and IBC that are

the subject of the Letter Agreement and the Ratification Letter, it is necessary for the Authority to provide certain assurances to IBC in connection with such loan, including that the Authority would vacate certain properties in the event of a default by the DGC and that the Authority will pay rent as long as it is in possession of the premises after such default, and therefore that it is in the best interests of the Tribe for the Authority to enter into the Letter Agreement and the Ratification Letter with DGC and IBC.

- 2. Approval of the Letter Agreement and the Ratification Letter. The Authority hereby approves the Letter Agreement and the Ratification Letter, as presented to the Authority for its review and approval, and further authorizes the Chairman of the Authority to conclude final negotiations of such Letter Agreement and Ratification Letter, if any, in consultation with the members of the Authority.
- **3.** Authorization to Execute and Deliver Agreements. The Authority hereby authorizes the Chairman of the Authority or the Vice-Chairman of the Authority to execute and deliver the Letter Agreement and the Ratification Letter to IBC at such time as such agreement has been rendered into a final form consistent with the Authority's directives and with this Resolution.

BE IT FURTHER RESOLVED THAT the Authority hereby approves the limited waiver of the Authority's immunity from suit to permit IBC, in the event of a default by the DGC in any of its contractual obligations to IBC, to enforce the Letter Agreement and the Ratification Letter; provided, however, that such limited waiver of immunity is hereby granted solely and exclusively to IBC by the Authority for purposes of enforcing the Letter Agreement and the Ratification Letter, and such waiver is nontransferable; and provided, further, that such limited waiver of immunity shall permit IBC to enforce the Letter Agreement in any state or federal court located in the States of Kansas or Missouri; provided, however, that such waiver of immunity shall permit only (i) an action or actions by IBC seeking a money judgment for rent during the time that the Authority is in possession of the premises (ii) an action or actions by IBC for injunctive, equitable, and other relief to compel the Authority to vacate the properties that are the subject of the Letter Agreement, and (iii) actions available under applicable law to enforce or execute under any resulting order or judgment(s), and not any other relief; provided, further, that nothing in the Letter Agreement is intended or shall be construed to impair the Authority's existing contractual obligations; provided, further, that the limited waiver of immunity granted hereunder shall permit only the recovery by IBC of any rents during the period of time, if any, the Authority remains on the lands described in the Letter Agreement in violation of such agreement, and shall permit the recovery of the costs of any litigation, including attorney fees and costs, or any other monetary sums or damages, or interest if the Authority is finally determined to be in default under the Letter Agreement.

BE IT FURTHER RESOLVED THAT the limited waiver of immunity granted hereby shall not permit any suit or recourse of any type against the Quapaw Tribe of Oklahoma (O-Gah-Pah) or any arm of the Quapaw Tribe or any other entity other than the Authority.


Standard Guest Room

- The upper trim is to be revised to be flush with the bottom of the header
- Remove glue on standard room wall and excess drywall mud on wall covering
- Add a shelf in the entry way corner for people to place their keys/ personal items.
- Tile insets to be re-installed 6/7/2012
- Provide a 10"x10" recessed shower shelf for standard rooms at the back wall.
- Shower Accent tiles to be installed as 1 under shower head, 2 on side wall and 1 on back wall
- Do we want a partial bench in the shower? Would we have to switch the shower head to the opposite wall to make sure the shower entry is not partially blocked? Make sure the shower door is not hinged on the side lite after the final decision is made.
- Make sure the receptacles at the bathroom vanity are all GFI type. CONFIRMED
- The toilet lid seems to be residential quality. Look into a slow lowering type lid. The elongated bowl seems small.
- Move the light switch that is currently on the wall after you enter the bed room on right to between the beds (At double queen rooms only)
- The luggage area should be near the entry, not near the window. Switch the desk and mini-bar locations to make this happen. *The Mock Up drawings currently show this correctly*.
- Remove the can light and upper duplex at the entry area above the mini-bar. (Should this remain since it is over the luggage area?)
- Move the 4-plex up and towards the edge of the desk. (Inside edge of desk) Leave the duplex below for the floor lamp.
- Remove the duplex outlets at the FCU and the opposite column cover.
- Make sure 4-plex convenience outlet is above night stand between beds
- In Double Queen Rooms, remove outlet in bed room along shower wall
- Move the receptacle in the entry area away from make-up wing wall and relocate to near entry door for vacuuming and not to wear out wall covering
- Delete duplex receptacles at make-up vanity and replace with a single 4-plex outlet.

1.5 Bay Suite

- Move toilet room door to make room for granite nosing and wood trim
- At make-up vanity, remove the two duplexes and replace with a single quad receptacle. Check against triple mirror to make sure they will not interfere
- Add a built in shower bench across the back of the shower.

- Check the height of the make-up vanity against the existing hotel. As installed this one seems too high.
- Add Schluter strip to edge of shower
- Want two sinks and larger bowls for vanity
- The colors for the tile mosaic are approved.
 - Side note At the 5/30/3012 walk through, the mosaic is to be centered in the door and become more rectangular. The borders will be moved 4" inward on each side (4'-2" x 3'-6)
- Find the tile for the vanity mirror surround from Phase 1. Possible savings will be up to \$40K
- T.V. for the living area should be along the divider wall
- The color for the VFCU cover is accepted.
- Investigate carpet pad type (Where does the ribbed pad go?)
